



ANNOUNCEMENT

The Associazione Amici della Scuola Normale Superiore di Pisa (Association of Friends of the Scuola Normale Superiore of Pisa) has received from the Fondazione Manlio Brozzi Onlus (the non-profit Manlio Brozzi Foundation of Grosseto), a donation of 10,000 euro for the funding of specific interventions in favour of students of the Scuola Normale Superiore in particularly serious situations of health, to permit them to proceed with their studies at the Scuola with greater ease.

In order to realise the full potential of the praiseworthy decision of the Fondazione Manlio Brozzi, the Associazione Amici, in agreement with the Director of the Scuola Normale and with his appointed head of the activities pertaining to disability and equal opportunity, has decided to distribute all or part of the sum available to students in particularly serious situations of health who apply for a grant with due justification.

The following procedure should be adopted to obtain a grant.

- 1) Students of the Scuola who intend to apply for the grant available must send an e-mail to amicisns@sns.it attaching a simple application on unstamped paper indicating:
 - a) their personal details;
 - b) the reasons for applying for the grant, together with any documentation supporting the request;
 - c) the amount requested and the use to which it will be put;
 - d) any other information or documentation considered relevant by the applicant.
- 2) The application must be signed by the applicant and integrated with the declaration from, which must also be signed, regarding the handling of his or her personal data (*please use exclusively the declaration form herein attached under letter "A"*).
- 3) The Association will examine all applications received, jointly with the Scuola, and reserves the right to request and /or obtain further information.
- 4) In awarding the grants, priority will be given to the seriousness of the applicant's health condition, his or her economic situation and the usefulness of the grant.
- 5) The Association reserves the right not to utilise the entire funding available. Any remaining funds will in any case be reserved for similar future interventions.
- 6) The identity of those applying for and obtaining the grant will not be made public.
- 7) The grant will be paid exclusively via bank draft drawn on a current account in the name of the applicant.

**INFORMATION REGARDING THE HANDLING OF PERSONAL DATA IN ACCORDANCE WITH ART.
13 OF EU REG. 679/2016**

The handler of the personal data transmitted by the applicant is the Associazione Amici della Scuola Normale Superiore di Pisa, situated in Piazza dei Cavalieri, 7, Pisa, e-mail amicisns@sns.it, in the person of the *pro tempore* General Secretary-Treasurer.

Any personal information provided (*personal details, contact and bank details*), also that pertinent to particular categories (*health details and so on*), will be handled for the purposes of processing the grant application presented and for paying out the grant should it be awarded.

The legal basis of the handling of the personal details transmitted by the applicant in the process of gathering data regarding application, selection and payment of the grant is, for the general data, the application itself (*art. 6, letter b*), of EU Reg. 679/2016) and, for data pertinent to particular categories, the consent of the applicant (*art. 9, letter a*), of EU Reg. 679/2016). All personal data will be handled using digital or paper documents in full respect for the principles of accountability, legitimacy, correctness, minimisation, transparency, integrity, exactness, confidentiality and proportionality.

All data transmitted will be handled for the purposes of assessing applications and awarding any grants, and will be kept at the location of the Associazione Amici della Scuola Normale Superiore di Pisa in paper or digital format for the time necessary for completing the activities regarding the procedure and for 10 years subsequent to any grant payout. Applicants may exercise the following rights, within the limits and conditions imposed by prevailing legislation:

- a) the right to revoke their consent to the handling of their data: in this case, it will not be possible to proceed with the evaluation of the application;
- b) the right of access to their personal details;
- c) the right to obtain the correction, cancellation or limitation of the handling of their personal details, in the cases and procedures referred to in articles 16-18 of EU Reg. 679/2016; cancellation is not permitted for data contained in the deeds, which must be kept by the Associazione Amici della Scuola Normale Superiore di Pisa;
- d) the right to portability of their data, in the cases and procedures referred to in art. 20 of EU Reg. 679/2016;
- e) the right to opposition to the handling of their data, in the cases and procedures referred to in art. 21 of EU Reg. 679/2016.

Applicants may exercise the above rights by applying to the Associazione Amici della Scuola Normale Superiore di Pisa at the e-mail address amicisns@sns.it.

In addition, applicants have the right to recourse to the Autorità Garante per la Protezione dei Dati (the Authority for the Guaranteeing of Data Protection) should they feel that their rights have been violated.
